# In Loving Memory of Juanita Hughes

Some people come into your life like a wrecking ball and give you no other option than to love them. Juanita Hughes is that person for me.

Juanita came into my life as an applicant for my Deputy Clerk position in December 2017. In the interview, she was full of energy, and I immediately felt a connection with her. At one point, she even sprawled out and simultaneously answered an interview question by saying, "Yea, and I'm Miss America!"

#### Uhhhh.....HIRED!

Her personality just spoke to me. I felt her vibrations, and I left that interview knowing she was my pick.

Juanita was my right-hand woman until health and family reasons forced her to retire in 2021. However, she remained a permanent fixture in my life regardless of her employment status.

Juanita was the life of the party ALL THE DAMN TIME! This woman was a good time, all the time. Never a dull moment. NEVER.

She was old enough to be my mom, and while she was very maternal to me, more importantly, she was one of my closest friends in life. She had a genuine heart of gold.

She brought out the best in me, and I loved how she made me feel. She energized me. She also brought out my orneriest side, and we spent a good portion of our time playing practical jokes on each other. LOTS of them. They were usually set in the maturity level of a pre-pubescent boy.

June 2023, we were having a great day. We were laughing and carrying on and didn't have a care in the world. Until she collapsed. She collapsed and wasn't breathing or responsive. Somehow, I was able to act quickly, and I immediately administered CPR until someone arrived and announced they were a nurse, and I stepped back. I then had an adrenaline dump and lost it. My friend was lying lifeless in front of me... dying.

There were so many wonderful people who jumped in to help. Complete strangers offering hugs and doing whatever they could in the moment. First responders arriving quickly and took control. Everything was a blur, and I don't even remember focusing on anything or anyone in particular because my critical thinking was completely depleted.

I rode with her by ambulance to the hospital, somehow knowing my friend wasn't going to make it. But still having hope at the same time. Even though she started breathing again, she was not responsive.

My clerks have become my closest friends in life. The people I work right next to and have seen some of the worst versions of me have also shared some of the best moments with me, and I love you all dearly.

While this is less of a "thank a clerk" post and more of a memorial post, it reminds us all to appreciate those around us while we have the chance. Juanita, I love you fiercely, my friend. I know you're already making new friends. Even though you are gone, you are sharing gifts with other families, and I find peace knowing you will live on in others.

Please keep the Hughes family and Juanita's long list of friends in your thoughts. We've suffered a devastating loss.
