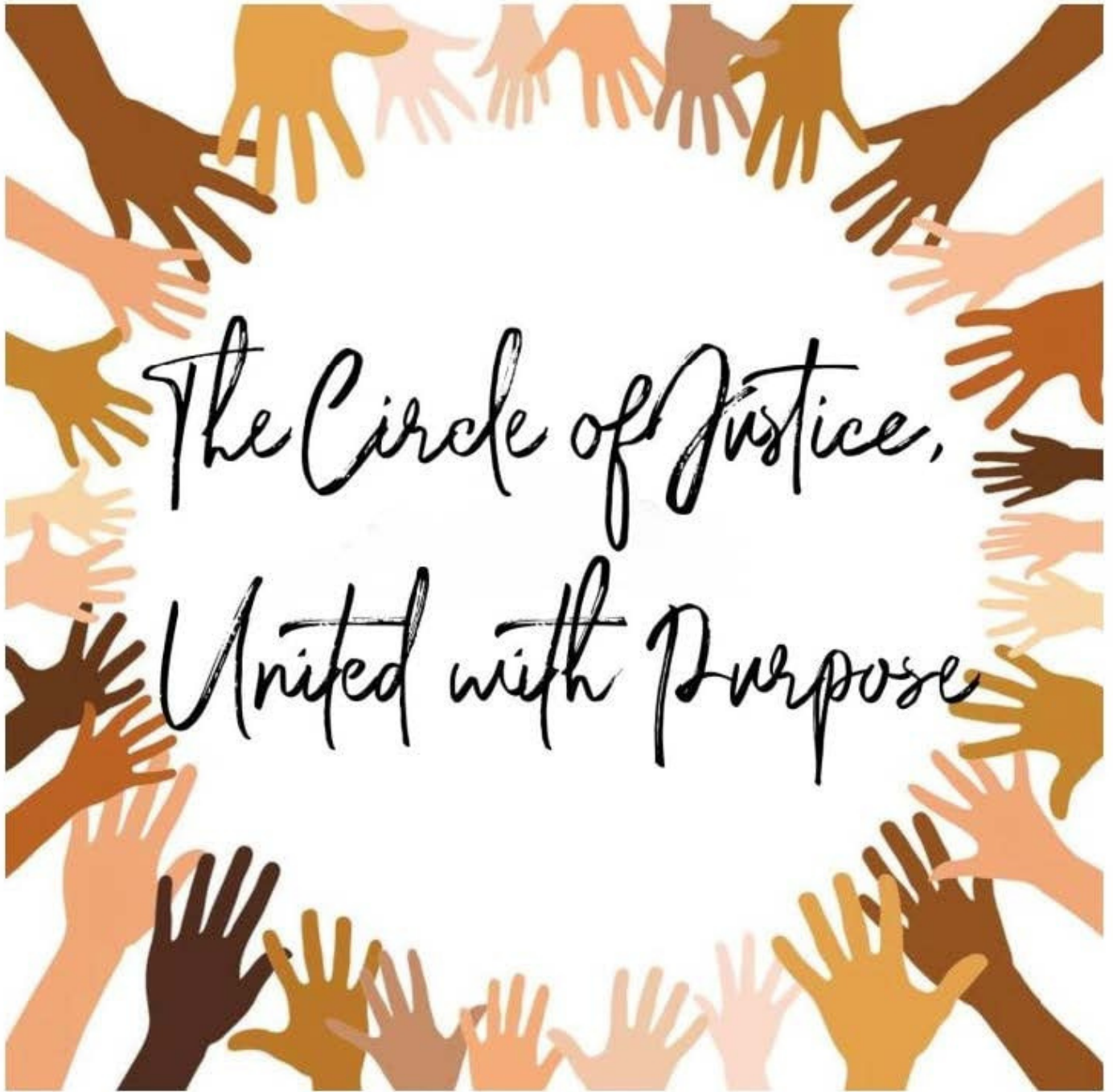

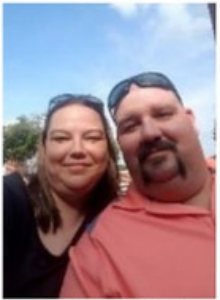

MMC was initially labeled Access My Tickets and is the first step towards self-represented litigant e-filing.
PA Clerks - PA Roundtable	Join fellow PA clerks as they tackle any topics or questions the group may have. Bring your questions, scenarios and how to's to share.
TAC Training	A TAC meeting is required for MULES or REJIS Terminal Agency Coordinator once per calendar. If you are still in need of this class, this will meet your requirement.
Drug Impairment Education	This presentation will cover the various marijuana extracts, how they're made, methods of consumption and how THC effect the body. There will also be a brief review of cannabis green labs.
