Cost of the hotel:

if guests are interested in calculating their charges ahead of time the rate is \$98 per night, and with the exempt status they are only responsible to pay the 5% occupancy tax which equates to \$4.90 per night. So, if the guest stays for all three nights it would be \$102.90 a night X 3 nights = \$308.70. This is the rate with tax exempt status. Please also note that the hotel does require cards to have on file for incidentals when they arrive. The hotel authorizes \$50 for the stay and we will release the authorization once the guest checks out, but this could take 3 to 5 business days to be reflective on the guests account depending on their bank.
